

## TERMS AND CONDITIONS

1. On receipt of a completed and signed application form and full payment is received, the title and risk of the casks will transfer to the purchaser from Manly Spirits Distillery (Whittaker Distilleries Pty Ltd).
2. Risk and Title to the purchased casks will lie with the purchaser. The purchaser must notify the Distillery in writing of any subsequent transfer of title.
3. A receipt and stock certificate with barrel number and expected date of maturation will be issued to the purchaser's nominated address on completion of the order.
4. The cask type selected by the purchaser will be ordered from the cask supplier and when delivered to the Distillery will be filled with Distillery grade single malt spirit at 63.5% ABV. This is typically 6 weeks after order.
5. The casks will be warehoused under bond in the Manly Spirits Distillery bonded store.
6. Purchase price includes the cask, single malt new make spirit and warehousing. The price includes Excise, GST and bottling.
7. Maturation for the Whisky will be defined as for 2 years for 20L casks and between 2 and 3 years for 50L casks, from the date of filling. For 50L casks the Distillery will nominate the maturation date for 50L casks within the 2 to 3 year period based on maturation.
8. Manly Spirits Distillery casks are insured against fire, theft and spoilage at replacement value. Manly Spirits Distillery insurance obligations end when the whisky leaves the Distillery, or 3 months after the purchaser has been notified of maturation.
9. Continuation of warehousing will be provided by arrangement. For each additional year of warehousing, the purchaser will be charged a warehousing fee.
10. At maturation and after bottling, the purchaser may pick up the filled bottles and empty cask from the Distillery. The Distillery can arrange freight at the purchaser's expense.
11. The purchaser may visit the Distillery by appointment, during normal working hours, to inspect their casks.
12. The purchaser's cask will be decanted and bottled at 47% ABV at the Distillery upon maturation. As the whisky will not be chill filtered, sediment

or flock may develop in the whisky over time. Shaking the bottle can easily disperse this.

13. All bottled Manly Spirits Small Casks will be bottled under the North Fort Whisky label as “Small Cask Release” with the cask type.
14. Overseas purchasers (Non Australian Domestic) can contact Manly Spirits Distillery to discuss withholding of local taxes from the sale price for potential export at maturation. If excise and GST are withheld from the cask payment, the purchaser is fully responsible for any excise, GST or export duties payable upon movement from the Distillery bonder store.
15. After maturation and bottling, the purchaser can elect to re-fill the cask under the terms and conditions of any Manly Spirits Whisky Small Cask Program underway at the time, at a discount of \$500 to the purchase price.
16. The purchaser is entitled to a 20% discount on drinks and cocktails at the Distillery Tasting Bar to a limit of 10 drinks per visit.
